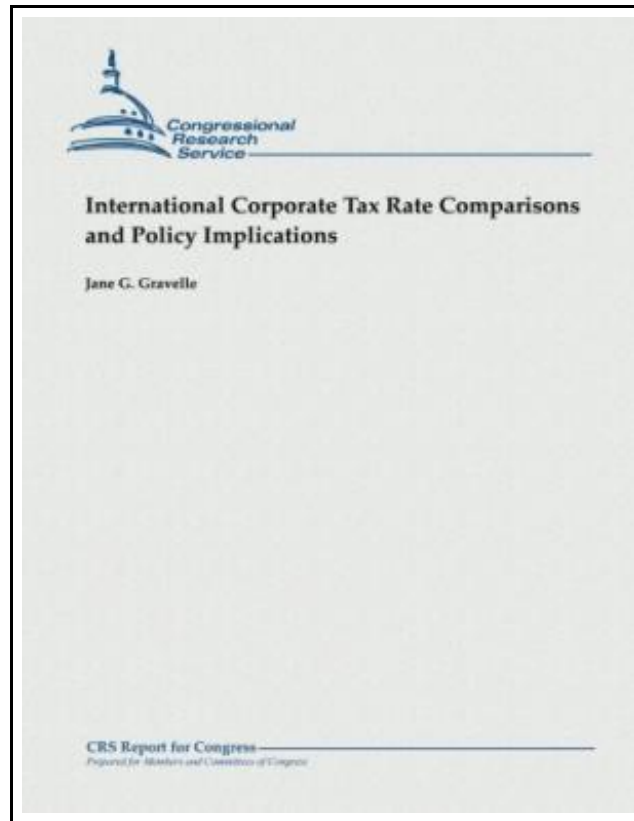

S. statutory tax rate is higher, the average effective rate is about the same, and the marginal rate on new investment is only slightly higher. The statutory rate differential is relevant for international profit shifting; effective rates are more relevant for firms investment levels. The 13. 7 percentage point differential in statutory rates (a 39. 2 rate for the United States compared with 25. 5 in other countries), narrows to about 9 percentage points when tax rates in the rest of the world are weighted to reflect the size of countries economies. (The OECD rates fell by slightly over 12 of a percentage point between 2010 and 2012) Regardless of tax differentials, could a U. S. rate cut lead to significant economic gains and revenue feedbacks Because of the factors that constrain capital flows, estimates for a rate cut from 35 to 25 suggest a modest positive effect...
